One-Time Payment Update

Within the <u>one-time payment form</u>, there is now a drop-down option for those who may want to donate without participating in an event and not wanting to utilize the payroll deductions. It is under the events tab, select "Statewide – No event/Donation only".

Payroll Deduction Clarification

For those of you who use the payroll deduction donation option, there is a point of clarification on that form. You can designate when you would like the deductions to stop, but all payroll deductions will start in January with the first pay period.



DHR Statewide Call Summary (10.05.23)

DHR Interim Administrator, Janelle White:

- Meetings have been held with agency directors; the feedback received regarding Luma has been
 overwhelmingly positive. Directors are happy modernization occurred simultaneously with Luma. It has
 allowed for smaller agencies to focus on their fiscal duties while DHR assists with HR needs. Directors have
 stated they feel the current statewide HR team is the strongest they have worked with.
- DHR Quarterly Strategic Planning is underway for Quarter 4. Janelle is very thankful DHR field staff filled out the Problems First survey to clarify areas of improvement on a statewide level. Topics for Quarterly Planning include:
 - Job Classification Renovation Plan
 - HR Employee Training Plan
 - Business Process Desk Guides Drafts
 - Establish Luma Reporting
 - Updating Communication Plan
 - Establishing a DHR Employee Appreciation Committee
- Janelle explained what the CEC (Change in Employee Compensation) Report is and what it is used for. We
 are revamping the report after two decades of the same format.
- Finally, Janelle welcomed Michelle Hermann as the new Bureau Chief over Systems and Support. She also welcomed Jen Weekes as the new DHR Financial Specialist Sr. Janelle gave an update on the recruitment of open positions within DHR:
 - DHR HR Systems and Data Manager
 - DHR Statewide L&D manager
 - HRO at Liquor and Lands

Bureau Chief, Michelle Peugh:

- Michelle announced that the rules for the 2024 Legislative Session have been posted for review on the
 Administrative Rules site in the October <u>bulletin</u>. She also developed a <u>Legislative Impact Statement</u> which
 gives an overview of the reasons specific rule deletions are being proposed.
- Updated HR staff on DHR policies including two new documents that have been posted on the DHR
 website related to the statewide compensation policy, Base Pay and Lump Sum Compensation Tools. There
 is also an update to the Out-of-State Telecommuting Policy that is specific to the State of Washington and
 their paid family leave program.
- Finally, Michelle gave an update on the Education Reimbursement Policy, with the addition of processing
 in Luma for reimbursement of tuition. The updated policy discusses in-depth the difference between
 taxable and non-taxable reimbursement benefits.



DHR Statewide Call Summary (10.05.23) Continued

Employee Support Service's Manager, Hanna Hall:

- Hanna brought attention to the HCM Weekly Newsletter from last week (9.29), the section at the bottom regarding October Customer Updates, they are updates for Luma and are large. SCO is looking at updates that will affect everyone and which ones they will have to test. These updates will take place on Wednesday, October 18th.
- Greg Schenk did a walkthrough of Cognos, similar program to IBIS and the recording can be viewed at https://idahogov.webex.com/idahogov/ldr.php?RCID=884557c2454b8c3ce99dac2a892bf352. The SCO team is adding more data fields into the data tree within Cognos.
- Finally, Hanna explained the latency in Service Milestones is due to a report not being created. These
 milestones are based on CSS hours within Luma.
- Emails have been sent from test environments; we are working on shutting them off.

Communications Manager, Brennan Serrano:

- Brennan went through and reviewed the DHR SharePoint site, highlighting document libraries, event calendar, news and announcements tab, program topics, and where to find past training recordings and weekly communications.
- The United We Care Campaign has begun and there are events going on statewide and within DHR to participate in. Brennan discussed the one-time payment and payroll deduction process with updates to when the deductions will begin.
