WELCOME

Chair Robertson welcomed everyone and called the meeting to order at 2:00 pm (Mountain). She noted that the meeting had been called to consider approving a letter to be submitted to the Federal Register in response to the decision of the National Institute of Standards and Technology (NIST), and the National Geodetic Survey (NGS), and several other federal agencies to adopt the "international foot" as the standard measurement of a foot in the United States.

Chair Robertson is in receipt of proxies (attached as Appendix A) for Keith Weber and Betty Conces.

LETTER TO FEDERAL REGISTER REQUESTING CLARIFICATION LANGUAGE FOR INTERNATIONAL FOOT

Mr. Arifuzzaman provided some background and explained that the Geodetic Control TWG supports the adoption of the international foot but noted that some states still use the "U.S. survey foot." Once adopted, the NGS plans to drop the term "international" and stop differentiating between "international foot" and "U.S. survey foot," which may lead to confusion and error. If approved, the letter will be submitted to the Federal Register and will request that the clarifying prefix of "international" be retained.

MOTION: Ms. Andersen moved and Mr. Smith seconded a motion to approve submission of the letter requesting clarification language for the International Foot to the Federal Register, as presented; the motion passed unanimously.

ADJOURNMENT AND NEXT MEETING

The meeting adjourned at 2:12 pm. The next regular meeting was scheduled for January 16, 2020.
